## PEDDLER, CANVASSER, SOLICITOR OR TRANSIENT MERCHANT REQUIREMENT CHECKLIST

This checklist is provided as a courtesy to aid in the preparation of a Peddler, Canvasser, Solicitor or Transient Merchant application. However, it is not meant to replace the City of Dickson's Ordinance or Regulations.

- \_\_\_\_\_ Complete Application for Peddler, Canvasser, Solicitor or Transient Merchant
- \_\_\_\_\_ Provide a Surety Bond in the amount of \$1,000 to the City of Dickson
- \_\_\_\_\_ 72 hour waiting period for background check from City of Dickson Police Department
- \_\_\_\_\_ \$55.00 permit fee. Methods of payment are cash, check, cashier's check or money order only. Permits are good for (14) days.
- \_\_\_\_\_ Written permission from property owner to set up on their property. Sales cannot be held on public street, sidewalk or right-of-way.

\*\*Locally grown produce is exempt from a permit but are still required to have written permission from property owner to sell.\*\*

\*\*Yard Sales conducted on commercial property inside the City of Dickson are required to have a permit - EACH SELLER MUST HAVE THEIR OWN PERMIT \*\*

\*\*Yard Sales conducted in yard of residence are not required to have a permit.\*\*
